### BACKGROUND

The *International Conference on System Theory, Control and Computing ICSTCC 2018* aims at bringing together under a unique forum, scientists from academia and industry to discuss the state of the art, the new trends in system theory, control and computing and to present recent research results and prospects for development in this rapidly evolving area.

ICSTCC 2018 joins four previous different scientific meetings hosted by "Dunărea de Jos" University of Galati (SIMSIS - International Symposium on Modelling, Simulation and Identification Systems), "Gheorghe Asachi" Technical University of Iasi (SACCS - International Symposium on Automatic Control and Computer Science), University of Craiova (SINTES - International Conference on System Theory and Control) and Politehnica University Timisoara (CONTI - International Conference on Technical Informatics).

Starting from 2010, all the editions have been technically co-sponsored by **IEEE Control Systems Society**. The Proceedings of the last seven editions are included in **IEEE Xplore Digital Library**. Moreover, the Proceedings of last two editions are indexed in **ISI Web of Science**.

In accordance with the Letter of Acquisition signed with IEEE, the **Proceedings of ICSTCC 2018** will be submitted for inclusion in **IEEE Xplore Digital Library**. The Proceedings will also be submitted for indexing in **Thomson Reuters Conference Proceedings Citation Index** (formerly **ISI Proceedings**).

ICSTCC 2018 will feature several kinds of presentations, including invited talks, contributed papers and special sessions. The outcome of ICSTCC 2018 can be a better understanding and development of some leading research areas: automation, control systems, robotics, computers, electronics and electrical engineering.

### **PAPERS SUBMISSION**

Full papers should be submitted using the PaperCept Conference Management System, by web upload at <http://controls.papercept.net/conferences/scripts/start.pl#STCC18>. All materials must be written in English. Submitted papers will undergo a peer review process, coordinated by the International Program Committee.

Papers submitted for presentation should contain original research, not published or being considered for publication elsewhere. All submissions will be tested for similarity and overlap with prior published material using the iThenticate tool. The results of this analysis will be made available to the Program Committee for evaluation. Possible violations of the IEEE ethics rules in publishing will be investigated by a dedicated committee.

The corresponding author of each paper will be notified of the result by e-mail. Accepted papers will be published in the conference proceedings, provided that at least one of the authors attended the conference and presented the paper. As part of the submission procedure, authors of accepted papers must send a signed Copyright Form for each paper. In the absence of such a form, the paper cannot be published.

The final form of the papers must meet IEEE pdf compliance requirements. Maximum six pages A4 in double column format are allowed. Authors may upload longer manuscript up to a maximum of eight pages! However, each page in excess of six will incur a charge of 50 Euros.

### **INVITED SESSIONS**

Proposals for INVITED SESSIONS in the conference topics are welcomed. People interested in organizing a SESSION should notify their intention at the address: [icstcc2018@ugal.ro](mailto:icstcc2018@ugal.ro). A proposal for an INVITED SESSION should include the title of the session, a half-page description of its topic, together with a list of at least six papers (authors and tentative titles) that will be submitted to the session. Papers submitted for a special session will be reviewed in the same manner as the regular papers.

## CONFERENCE FEES

- Early registration fee (before July 27, 2018): 325 Euro (275 Euro for IEEE Members);
- Late /onsite registration fee: 375 Euro (325 Euro for IEEE Members);
- Early student registration fee (before July 27, 2017): 200 Euro;
- Late / on site student registration fee: 225 Euro.

A registration fee covers: attendance at all sessions, conference materials, coffee breaks, lunches on the days of the conference, welcome reception and gala dinner. It also includes an electronic copy of the conference proceedings. Regular registrants are allowed to upload two papers. Student registrants are allowed to upload only one paper. Additional papers may be uploaded for 125 EUR each.

### **CONFERENCE VENUE**

Sinaia is one of the most famous and oldest mountain tourist resorts in Romania, known as "The Carpathian Pearl". Situated in breath-taking mountain scenery, Sinaia is located at 120 km distance from Bucharest. Blending astonishing beauty of nature with picturesque architecture, Sinaia is a formal royal residence. ICSTCC2018 will be hosted by the **International Centre for Conferences – CASINO SINAIA**.

The Sinaia Casino was built at the initiative of Carol I, first king of Romania. Construction began in 1912 and was finished a year later. The main shareholder in the Casino was Baron of Marçay, a shareholder in the Monte Carlo Casino. The opening was celebrated with a piano recital by George Enescu, becoming a major attraction between the wars.
